



The EBS LL.M. programme offers the opportunity for academically excellent, self-reflecting and culturally open-minded students, who have obtained an undergraduate degree in law or business studies, to achieve a first-class Master’s degree in “Global Business Law”.

The LL.M. programme “Global Business Law” is a graduate programme in law. Through its focus on international aspects of business law, the programme qualifies graduates to master future challenges in an international environment. The one-year consecutively taught programme enables graduates to independently develop profound solutions for problems in global business law, both from a legal and an economic perspective, putting the learnt methods and theories into practice.

At the international level, highly qualified lawyers are in high demand, particularly if they are able to grasp economic contexts and understand business relationships.

Thus, interdisciplinary studies in law and business, qualifying students to achieve a sound understanding of the underlying economic issues of legal problems in global business law, are paramount for the design of the EBS LL.M. programme. This interaction of a sound legal and economic education combined with a consequent orientation on international aspects is what makes this Master’s programme innovative. Global Mergers & Acquisitions

M&A transactions are complex processes that require diverse knowledge and skills ranging from legal to financial topics. Making use of the unity between the Law School and Business School, this module provides a deep understanding of M&A from both a legal and a financial perspective. After learning about the legal and economic basis of M&A, my students will focus on practicalities of M&A deals, post-merger integration and restructuring processes, and legal boundaries of M&A transactions. On top of your theoretical knowledge, you will also participate in a simulation of an M&A deal, where you will put into practice what you have learnt in this module.

Global Banking & Finance

In this module, I focus on the interdependency of law and business in global banking and finance. I introduce you to both the economic background of capital and lending markets as a funding source for the economy. In order to ensure that you gain an extensive understanding of the laws that shape global banking and finance, this module will cover banking and capital markets law. To ascertain that you can utilize your expertise in transactional work, I illustrate M&A finance. The overall aim is to familiarize you with the legal and economic backgrounds of global banking and finance, enabling you to identify their implications on financial markets in your future career.

Global Dispute Resolution

Dispute resolution is becoming increasingly important, especially with regard to conflict solving on an international scale. With my students, I explore the challenges of multinational disputes at public courts and how procedural risks can be exposed and managed effectively. Further, this module looks into alternative ways to solve a dispute, particularly through arbitration. You will receive the opportunity to understand the importance of international commercial arbitration as well as investor-state dispute settlement. Together, we will assess the issues arising from the growing number of compliance and regulatory requirements for regulatory disputes with a focus on their global implications. Completing this module enables you to effectively deal with the complexity of international disputes, no matter in which way they ought to be settled.

Global Digitalization & Mobility

Globalization has prompted the world to develop into a “global village”: production chains are internationalized – a car manufactured in one country has parts from all over the world – and multinational companies shape the global economy. In this context, the legal framework of supply chains and logistics becomes increasingly relevant. In this module, you will be introduced to the principles of trade and transport law as well as to the design and planning of supply chains. Then, we will explore the current and future challenges of digitalization and mobility, looking at the emerging regulatory challenges of technological progress, and changes in business models driven by social and technological developments. The course encourages students to take a leading role in shaping the way we approach globalization.

EBS requires LL.M. students to have well-developed analytical and reasoning skills. You also need to have an above-average willingness to learn and work hard, have good communication skills, be able to work under pressure and be motivated to make a difference.

Visit us at www.ebs.edu/application and start your personal application process. The LL.M. admission process consists of three steps:

1 ADMISSION PROCESS

To be considered eligible for admission to our LL.M. programme, you will need to provide proof that you:

- Hold a university entrance qualification and a Bachelor's degree or equivalent with 240 ECTS credits (applicants with fewer ECTS credits can qualify for up to 60 ECTS credits from previous working experience)
- Are proficient in English (TOEFL, IELTS or equivalent)
- Possess sufficient knowledge of methods and jurisprudence in the case of not holding a law-related degree (having done law-related courses that add up to at least 30 ECTS)

2 INTERVIEW

If your application documents meet our admission requirements, we will invite you to take part in an interview, which is held either on campus or via videoconference. The interview consists of a 45-minute personal talk, during which your motivation, social competence and communication skills will be assessed.

3 DECISION

The admission process is both demanding and exciting. We know that and ease the burden on our applicants by communicating the results as quickly as possible to enable everyone involved to plan dependably at an early stage.
